Subject: Statement on recovery of biomass of Dr. Hilen Tukoss.

On June 8th YC117, a group of individuals with various corporate loyalties discovered the remains of a Buzzard-class covert ops frigate in the uncharted system of J174618.

After study of telemetry from the vessel's last fluid router contact, and confirmation of the vessel's CISC, along with analysis of footage handed over by The Scope Galactic News Network and Eifyr and Co, it was ascertained that the remains of the vessel discovered by the parties listed below belonged to the Buzzard class "Arek'Jalaan", last piloted by the late Dr. Hilen Tukoss.

Along with the remains of this vessel, a significant quantity of biomass believed to be the remains of Dr. Tukoss was discovered in the vicinity of an unidentified structure, and was subsequently partially recovered by the parties listed below.

Analysis of the biomass recovered was carried out, with DED supervision based on the assumption that once all findings had been released, the biomass would be turned over into the hands of the Directive Enforcement Department, in order that formal identification, closure of the missing person's case and proper treatment of the remains of Dr. Tukoss be administered.

Usually, these actions lie outside the responsibility of the scope of the Directive Enforcement Department's responsibilities, however due to the unique nature of Dr. Tukoss' citizenship status, and the fact that he presently has no legal citizenship status, the CONCORD Assembly assumes responsibility for his civil and legal rights after the revocation of his State citizenship, pending his approval for Republic citizenship.

Given the high profile of this case, and the fact that his case number has been listed as a matter of interstellar security, the responsibility of execution of his legal and civil rights lie with the Director of Operations for the Directive Enforcement Department.

Rights to Salvage:

Rights to salvage are outlined in Article 8 of the Yulai Convention (Trade and Salvage). Specifically, Article 8 Section B explains that rights to salvage on destroyed vessels lie with the individual responsible for the destruction of the vessel, or the individual who makes first claim to the salvage upon its discovery.

Article 8 Section B (2) explains that rights to salvage do not include claims to biomass, and the responsibility for any persons, living or dead, discovered aboard wreckage lies with their immediate next of kin. If no competent next of kin exists, responsibility for those discovered lies with the government of their citizenship.

Article 8 Section B (2a) states that the Directive Enforcement Department can assume right to biomass in matters of interstellar security, when an investigation marked as such remains open, regardless of citizenship.

Situation:

After a meeting of the Inner Circle and senior DED command on the morning of June 25th, the following communication was issued to those listed in the "To:" field by Brigadier General Odo Korachi, Commander of the Directive Enforcement Department's Genesis Fleet:

Ladies and Gentlemen,

The Directive Enforcement Department would like to offer thanks for your work on the report provided to the Inner Circle Re: the late Dr. Hilen Tukoss, and for the analysis of the tissue samples that were recovered from wreckage found in J174618.

After a meeting with the Inner Circle this morning, and after public request for all tissue samples to be turned over to the Directive Enforcement Department for analysis and formal legal confirmation of identity on June 8th, concerns have been raised regarding the intentions of your group.

With this in mind, and with the comments of pilot Lucas Raholan factored into the situation (https://forums.eveonline.com/default.aspx?g=posts&m=5822828#post5822828) the Directive Enforcement Department is hereby making a formal final demand for the handover of all biomass samples to the DED for analysis and biometric processing.

Pilot Raholan is hereby being informed of a 24 hour grace period, beginning at the timestamp of this message, during which the samples can be handed over to myself via 14 day contract. Mail confirmation of this contract must be provided once it is set up.

Failure to hand over the samples within 24 hours will result in all recipients of this mail being elevated to outlaw status on all DED records.

This will include standings toward the CONCORD Assembly and the following corporations reverted to -10.0 status:

- CONCORD [CONCO]
- DED [DED]
- Secure Commerce Commission [SCC]
- Inner Circle [ICR]



In addition to this, the Inner Circle may see fit to rule in favor of a Directive Enforcement Department warrant to seize equipment pertaining to the ongoing investigation into the death of Dr. Tukoss by force, under Article 5, Section C of the Yulai Convention, which would then not be limited purely to the biomass in question.

The Directive Enforcement Department requests correspondence from Pilot Raholan within 24 hours to arrange handover of all biomass relating to the investigation.

Failure to correspond will be regarded as non-compliance with this demand, and will result in the enactment of aforementioned legal action.

Capsuleer Response:

Those targeted by sanctions are as follows:

Celes Tenebrae (PISC – 193082253) Lucas Raholan (PISC – 92201775) Makoto Priano (PISC – 422609556) Scherezad (PISC – 1046500924)

Pilots have refused to comply with demands from the DED to hand over remains.

Pilot Lucas Raholan has been identified through fluid router CISC tracking to have relocated to Anoikis in a Tengu class vessel (CISC 1016243221102) with the following registered subsystems, carrying a contingent of personnel and equipment:



- Defensive Supplemental Screening
- Electronics Emergent Locus Analyzer
- Engineering Capacitor Regeneration Matrix
- Offensive Covert Reconfiguration
- Propulsion Interdiction Nullifier

Further Action:

Failure to comply with demands has resulted in formal filing of standings reset request for the individuals listed, which once approved by the CONCORD Assembly, will be enacted in approximately 14 days. Standings to all divisions, corporations and organizations within the CONCORD Assembly will be set to -10.

In addition to this, for the willful endangerment of the remains of Dr Tukoss and the DED Investigation, the following bounties will be issued against the named pilots for their execution, should the remains of Dr. Tukoss not be handed over to the DED as requested within the next 48 hours:

- 50 PLEX Lucas Raholan (PISC 92201775)
- 50 PLEX Makoto Priano (PISC 422609556)
- 25 PLEX Scherezad (PISC 1046500924)
- 25 PLEX Celes Tenebrae (PISC 193082253)

Further sanctions are also under review, including economic and political sanctions as well as CONCORD Assembly standings reviews against the following corporations:

- Itsukame-Zainou Hyperspatial Inquiries Ltd. [IKAME]
- Revenent Defence Corperation [R.D.C]
- Societas Imperialis Sceptri Coronaeque [SFRIM]

Executive officers from these corporations will be contacted as appropriate, should the need for further sanctions arise.



Timeline For Action:

00:00:00 29/06/YC117 - Final deadline for handover of remains of Dr. Tukoss.

00:00:00 29/06/YC117 - Issue of bounties on pilots as outlined above in "Further Action".

00:00:00 06/07/YC117 - Permanent standings adjustment as outlined above in communication.

00:00:00 20/07/YC117 - Potential sanctions against listed corporations.

The governments of those involved in this situation have been informed of the fact that citizens and organizations under their jurisdictions may potentially be classified as outlaws by the Directive Enforcement Department in the coming days and weeks, and have been instructed to take the appropriate measures to ensure the relevant departments within their organizational structures are aware of this change in status.

As always, the door remains open for these individuals to come forward and treat the remains of Dr. Hilen Tukoss with the respect deserved.

It is the hope of the Directive Enforcement Department that those involved will see sense, and deliver the remains of Dr. Tukoss to the proper authorities, so that he may be formally and legally identified before being laid to rest in a manner befitting his contribution to the cluster and his field of work, rather than his remains continuing to be paraded around the cluster in some form of abhorrent anti-authoritarian display of personal pride.

The individuals in question are free to contact Brigadier General Odo Korachi should they feel the urge to comply with interstellar law.
